***Even if you would like your hair down, if it requires the use of a flatiron or curling iron then it is considered an updo and will be charged as such**

50% down to guarantee wedding date and appointments

Cancellations - Any cancellations made with less than 14 days notice will be charged to the credit card associated with this contract. The entire cost of the cancelled service(s) will be placed on the credit card. The remaining amount is due 14 days prior to the schedule date of service.

Late arrivals- If a wedding party is more than one hour late without making contact with us, the assumption is the client is a no-show. In this case, the client forfeits all deposits and payments. If a wedding party is late for the scheduled service appointment time and notifies us of a new arrival time, stylists may or may not be able to accommodate the new arrival time. If the scope of the original contract can't be fulfilled services may be reduced; however clients are liable for the original amount.

Travel fee- If you request for stylist to do hair and make-up on site there is an additional \$100.00 travel fee per stylist.

15% Gratuity is required and we ask that it be paid in cash.
